What is a Roth contribution option?

In the Q M BOO pretax contributions have the potential to accumulate tax deferred and withdrawals are taxable! With the Roth option, your after-tax contributions have the potential to accumulate tax free. Withdrawals after age 59½ are tax free if distribution is no earlier than five years after contributions were first made. These tax benefits are similar to a Roth IRA. Additionally, Roth contributions allow higher contribution limits than a Roth IRA.
